A few unexpected and unplanned things are likely to come up too.

I am very grateful that most of my life is filled with wonderful people and tasks. But, Lord have mercy, I need to remember to breathe, take walks, appreciate the trees in their autumnal glory, spend time with the people I love, exercise, and rest. I need to balance all that God has given me.

St. Timothy's Walkers

Get out your walking shoes! Reston Interfaith is honored to be a beneficiary of Fannie Mae's Annual Help the Homeless Walkathon. Last year, Fannie Mae's walks raised over \$7 million, one hundred percent of which came to organizations that work to help prevent and end homelessness, including Reston Interfaith. Over 1,000 Northern Virginia community walkers helped raise nearly \$70,000.00 specifically for RI, allowing us to provide shelter and permanent housing for over 600 people. This fantastic outcome was made possible by the support of local individuals and organizations.

Abundant Gifts

Remember the Church in Your Estate Plans

The *Book of Common Prayer* includes the following rubric: "The Minister of the Congregation is directed to instruct the people, from time to time, about the duty of Christian parents to make prudent provision for the well-being of their families, and of all persons to make wills, while they are in health, arranging for the disposal of their temporal goods, not neglecting, if they are able, to leave bequests for religious and charitable uses."

As Christians, we are each caretakers of the unique gifts given to us by God during our lifetimes. As Christians, we acknowledge these gifts by giving back—giving our love, our time, our expertise and our physical possessions. In particular, how we dispose of our possessions before departing this life makes a statement to those who follow us. Episcopalians who wish to set an example with their lives and who wish to continue their stewardship after death may provide for their parish or the wider ministries of the Church in their wills. A simple bequest can benefit congregations, church social service agencies, programs of the Diocese, seminaries, camps, colleges and other Episcopal institutions. There are several ways you can use your will to advance ministries you care about:

- You can leave a percentage of your estate for ministry;
- You can leave a specific amount of money for ministry;
- You can leave the remainder of your estate to ministry after other bequests are made;
- You can leave specific property (your IRA, which would otherwise be taxable, or appreciated property such as stocks or real estate) for ministry;
- You can create a trust to provide life income to a survivor and then designate a ministry as the final beneficiary.

In addition to wills, a number of other planned giving methods are also available, ranging from gifts of life insurance to gifts that provide income during the donors' lifetimes, such as gift annuities and charitable trusts.

Where Does Your 6.4 Cents Go? *Follow the Dollar*

Do you ever wonder just what happens to that one dollar you put in the collection plate on Sunday? A large majority of it goes to support the ministry of your local parish. But just over 6.4% goes to support the work of the Diocese. That money sends missionaries across the globe, builds new churches and provides professional support and resources for clergy and lay leaders. It supports the everyday ministries of the Diocese that support local churches, from communication to transition ministry to the ordination process.

The Jeanie Schmidt Free Clinic

The Jeanie Schmidt Free Clinic (JSFC) extends its thanks to St. Timothy's congregation for their generous participation in the school supplies drive in August. There were 66 bags of school supplies assembled and distributed to children at the conclusion of their school physical due to these contributions. In addition, 75 small bags of toiletry items donated by St. Timothy's were given out to adult patients. JSFC thanks you for your continued support of its mission to provide access to health care for low-income uninsured individuals in Herndon, Reston, Centreville and Chantilly.

The Jeanie Schmidt Free Clinic provided services to 505 children and 212 adults for a total of 1,809 appointments over a 12 month period in 2007-2008. *New Opportunity*

Tickets are \$5 each or 5 for \$20. The Service Ministry's goal for St. Timothy's is the purchase of 80 tickets or \$400.

Ministry of the Month: Making the Case for Stewardship

We all take solace in the notion of home—a location where we feel safe, secure, and welcomed. Sometimes home is a state of mind, an ideal that represents more than just the physical place we lay our heads at nights. Home may be something that some of us are still searching for. Whether we're finishing up at work, running errands, or even playing in a softball game, making our way home is on everyone's to-do list.

As children, home is provided for us until we can venture into the world and define what we will call home. But, the place we will live or the special peace that we seek is not something we receive automatically—it must be attained. Sooner or later, we all come to the realization that home is not something we are due. We must work for it.

St. Timothy's is our church home—a place we visit weekly and return to for special occasions in our lives—weddings, baptisms, and other memorable events. It's a place where we sing Christmas carols in December and celebrate the resurrection of Christ at Easter. St. Tim's is a place of peace. While there, we are welcomed by neighbors and friends who share our belief in God and Episcopal faith. From there we go in peace, refreshed and nourished, to love and serve the Lord.

However, St. Tim's is not a tax-free inheritance, but a home we must work for. The sanctuary, the meeting spaces, the beautiful grounds, and the people who administer to us (i.e., the clergy, music director, parish administrator, sexton, and nursery supervisor) all require something from us—a commitment, an offering to keep the Word of God and the many missions of the Episcopal Church alive and present in our community.

The Stewardship Ministry members have the enormous task of reminding us of this responsibility . . . and they do it with poise and conviction. They conduct fundraising campaigns and educate parishioners about the importance of making financial pledges to assist the Vestry to budget church resources. Some of our members may not realize that our church receives no financial support from the Diocese; St. Tim's relies solely on the generosity of the congregation to maintain its building, clergy, staff, ministries, and outreach programs.

Stewardship Ministry Chairman Paul Conroy says, "Being members of St. Timothy's requires each of us to be good stewards of the church. God is calling us to do his work, but we need the resources to move forward."

Stewardship's mission is simple and straightforward. "Recognizing that we are created by God and that all we have comes from God, the Stewardship Ministry challenges, educates, and supports the people of St. Timothy's in becoming faithful, generous, and thankful stewards of the time, talent, and treasure entrusted to us."

The Stewardship Ministry is in the process of announcing its plans for the 2009 pledge campaign. The theme for this year's campaign is *Abundant Giving, Abundant Life* and activities include parish dinners with information and entertainment. All members are encouraged to attend. The Stewardship Ministry will also make presentations at services throughout the fall.

The people who give of their time to run the church's stewardship efforts include Paul Conroy, Alain Bashore, Chris Brock, Rob Bumbary, Jim Hendrick, Katie Mazza, and Susy Nixon. The Vestry liaison is Senior Warden Duncan Hutcheon and Frank Martin helps manage the Ministry's records.

Stewardship reminds us that St. Tim's is ours and, accordingly, we are responsible for it. During these economically challenging times, many of us must make decisions about what we can eliminate from our budgets and how we can more effectively allocate our resources. Saint Paul in Chapter 8 of his second letter to the Corinthians tells them that what we present to others of our material wealth, we will collect in spiritual prosperity. Please think seriously about what St. Tim's means to you and your family, and please give generously.

To My Fellow Parishioners at St. Timothy's Episcopal Church:

As some of you might know I have been engaged in the discernment process to determine my role in the Church. A lot has happened in the last year and a half. I have been through a parish discernment committee here at the parish. Six wonderful members of our congregation were willing to listen to the Spirit, help me through my fears, sound out my gifts and then come to a clear role for me in my service to the Church. It was determined after much thought and prayer that I was called to be a deacon in the Church. I was given the go ahead to pursue Holy Orders via the Diocese.

I have met with the Committee on the Diaconate at Roslyn in Richmond on June 13th. The questions were difficult and thought provoking yet ultimately revealed a lot about me and my relationship to God and my sense of calling. I was accompanied by some of the members of the parish discernment, Fr. Brad and my wife Kim. On my way home the Chairperson called me and told us that that I was recommended as a Postulant to the Holy Orders of Deacons in the Episcopal Church! Next step was to meet with the Bishop.

I have met with Bishop Lee in Richmond on August 13th. We discussed the role of deacons in the Church and what might be expected of me in the future. He supported the decision of the Committee on the Diaconate to begin training.

Most recently I attended a Deacon Retreat at Roslyn to meet and get to know the other Postulants over the weekend of August 22-23. We spent a most enjoyable and prayerful time getting to know one another.

The Deacon Formation Institute began this past Saturday September 13, 2008. It should last 12-18 months. We will meet one Saturday a month for theology, Anglican Spirituality and other courses. Ordination is scheduled for sometime in early 2010.

I ask for your prayers as I go through the process. Thanks again to my Parish Discernment Committee, Fr. Brad, Leslie, and to you my fellow parishioners.

Flu Shots

Who: Must be 18 years of Age!!!!

What: Influenza Vaccine which contains strains A/Brisbane/59/2007 (H1N1)-like, A/Brisbane/10/2007 (H3N2)-like, B/Florida/4/2006-like. This is the vaccine for the season of 2008-2009. The flu virus indicated on this consent form is for this flu season. Seventy-five to ninety percent of all people who receive a flu vaccine are completely protected. The remainder have partial protection and will have greatly lessened symptoms if they do contract influenza. The vaccine will begin to provide protection in about one to two weeks after the shot is given. Each year there is a new strain of flu, so you must be vaccinated each year to be protected. Do Not Receive the vaccine if you have an acute illness especially fever since the vaccine will not be fully effective and you will become more sick. All viruses in the vaccine are killed so they cannot infect anyone with the flu. The immunity from the vaccine lasts about a year so earlier you receive the vaccine the better. This shot will not protect you against other illnesses that resemble the flu. All needles and syringes are sterile, are one-time use and are safely discarded.

Where: Henry Hall (if available) or B-1 signs will be posted day of administration. Cost: \$25.00??? influenza and \$45.00 Pneumonia(only can be given to persons 65 or older and only first time recipient or greater than 5 years since last given. Pneumonia to be received only twice in your life time!!! Aetna insurance holders and Medicare Part B will have consents submitted to the agencies for payment.

Pre-Cycle -- It's In!!

What The Intelligence Group has observed as a new trend called "pre-cycling" is really just the growing trend of being aware of your choices up-front. If you purchase a product in a non-recyclable container (a plastic not coded as "1" or "2") then the consumer has no choice but to throw it out or try to figure out a way to reuse it. Today, many "green" consumers are trying to reduce their recycling before they buy the product -- a growing trend so says The Intelligence Group!

Consumers who pre-cycle aren't just content with throwing cans and bottles in the recycle bin and letting waste management sort it out. In its Report, The Intelligence Group found that 45% of trendsetters and 14% of mainstream consumers have "cut down on bottled water purchases" in the past six months, while 49% and 16% respectively have "cut down on use of plastic bags" during the same period. "It's not just about how you dispose of [products and packaging] anymore," said Melissa Lavigne, director of marketing for The Intelligence Group, which is a division of CAA. "It's about being conscious about products you buy in the first place. That's the idea behind pre-cycling." What a great idea to preserve and protect the resources God has given us!

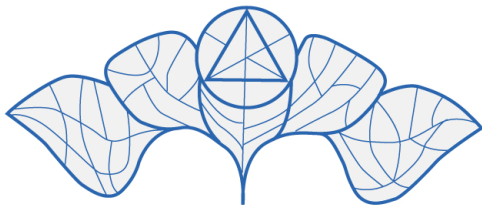
